

COOKIE INFORMATION

The KELER Group websites (www.keler.hu; www.kelerkszf.hu) apply anonymous user identifiers ("cookies") in the course of providing certain services in order to improve the quality of use and to make it easier for the user.

1. What are cookies?

An anonymous user identifier, simply called cookie, is a series of signals that can be used to uniquely identify a computer or store profile information that service providers place on a user's computer. It is not in itself able to identify the user personally in any way, but only to recognise the user's computer.

Some cookies are temporary and disappear when you close your browser, while some convenience cookies are stored on your computer for a period of time, as set out in the table below, so that if you visit our website regularly, your browser will remember your previous settings, so you do not need to accept our cookie notice again each time you visit or regularly adjust your filtering preferences to suit your needs.

By using our website, you acknowledge that we will place the essential cookies of the types detailed below on your device and that we will use this information in accordance with this policy, unless you have set your browser to disable cookies.

2. The purpose of the cookies we use

Some of the cookies used by our websites are essential for the secure and proper functioning of the site (session cookies) and are used to keep the site running, while other cookies are used to make the site more convenient for you. The purpose of recording your preferences and usage habits is to make the site easier to navigate and thus to use.
