1. Changes

14.06.1999. Account segregation

Import order format is not changed; it is completed as it used to be.

Statement export is changed as follows:

- Fields were added to statements that were prepared on the stock exchange settlement account. Account segregation resulted in the stock exchange settlement account being divided (own and client subaccount). In the export format of statements the subaccount code and name, account type and account type name were put at the end. At the same time a new block (*ASUM type lines) is generated that contains the subaccount amount levels.
- Securities basic denomination field is changed from whole number to a fraction with 2 decimals. This applies to all securities statements, the list of non-marketable securities and the securities master data. The length of the basic denomination field did not change in the statements and the securities master data, it was changed only for non-marketable securities. The basic denomination field contains the decimal point as well, e.g. 10000.00
- In certain statements the nominal value field became wider. The field is terminated in the middle of lines (KID adds spaces to fill the value) and the field is put to the end of the line.

22.11.1999. Securities account history, securities history

In menu items securities and securities account history the export button becomes active once the search is launched. Export can be completed if the search had at least one item in the result list.

23.11.1999. New blocks in the stock exchange trade confirmation

The export of the stock exchange trade confirmation is extended with two new blocks: collective guarantees, positions pending fulfillment. New blocks are shown in the export only if the original data contained such block also.

23.11.1999. Item status in statement T708

In Statement T708 the status field of items was added. Its value is H (error), F (uncovered) or T (cancelled). The status field can be found in the export at the end of line items (T708TET), its length is 1 character.

21.04.2000. New statements T711, T712

KELER issued two new statements for securities issuers. These are prepared upon the physical-dematerialized conversion of securities. This informs the issuer on the persons, the accounts that keep its securities and the quantity held.

25.05.2000. Submitting VIBER items

KID can apply two processing methods to receive orders. One is the traditional BATCH processing, the other is VIBER. One order file can contain items with the same processing method that is to be stated in the file header after the key word HEADER. For example:

```

HEADER VIBER
..... first item .....
.....
..... third item .....
TRAILER      3

```

If there is nothing after the key word HEADER, KID automatically decides on the processing method to be applied based on the type of the order. For example in case of OTC VIBER, for transfer and blocking BATCH.

20.11.2000. DER system export description

On 20 November, 2000 KELER Rt. launched its new derivative (DER) system. Downloaded statements can be exported.

23.02.2001. Extension of statements T400, A400

The reason of sending field was added to the statements.

23.02.2001. Extension of statements T705, A705

E Day obligation and reason of sending fields were added to the statements.

23.02.2001. Description of new statements T443, T450, T446, T447

In relation to TEA KELER introduced new statements.

01.03.2001. Statements T410, A410

So far in statements T410, A410 in the last summary line the liabilities of the KELER member were shown in one field only. Now it is broken so that regardless of the date of the statement and the sign of the liabilities it can be clearly decided whether it refers to a payment obligation by the KELER member to KELER or an amount is to be transferred by KELER to the KELER member.

12.07.2001.

KELER introduces the Deviza Nyilvántartási Rendszer (DNR) (FX Register). In DNR there is a possibility to import 4 new orders: Deviza átutalás (DEV) (FX transfer), Deviza átvezetés (DVE) (FX transfer), Deviza konverzió FX (DHK) (FX conversion), Deviza avizó

(AVI) (FX advice), and Devizanyilvántartási értesítő (FX register advice) and Deviza árfolyamok (FX rates) can be exported.

12.07.2001.

Securities blocking and unblocking orders were added a new blocking group: securities blocking due to 24-DNR.

14.08.2001.

Management of capital repayment bonds, introduction of actual capital value field at the end of item lines. Statements involved in this change are statements T522, A705, T761, E761, T768, T700, T708, O101

23.08.2001.

Introduction of statement T541 (List of unfulfilled VIBER blockings and unblockings)

21.09.2001.

DER developments: accepted deals data structure extended with 'deal price' field.

28.11.2001.

FX OTC developments: OTC PROMPT, REPO, REPO extension, REPO with delivery and extension of REPO with delivery orders were added a currency field and a seller/ buyer field each. Default currency is HUF, thus the already existing OTC interface can be used for the purpose so far without change.

EÉR statements: introduction of statement T751; changes in statements A705, T705 due to multinet T-x pieces changed to E+x pieces; individual accounts are also shown in statement T700, the type description of individual accounts is put to the end of the lines; introduction of new statement T444.

OTC statements: new statement O100 on unfulfilled items with gross settlement, new statements V101 and V100 on FX gross settlement items that are fulfilled and unfulfilled

12.04.2002.

CCP developments: statements A400, T400, T405, T410, T427, T428 changed or newly incorporated into KID.

In EÉR system Prompt market confirmation and renaming Day E to SD, Securities master data supplemented with securities types.

Collateral statements: introduction of collateral statement and uncovered collateral list.

09.04.2003.

EÉR master data: introduction of securities main account master data

Orders: introduction of securities position settlement (ERE) order.

2003.04.17.

EÉR statements: introduction of statement T550, introduction of statement T772

09.05.2003.

EÉR statements: correction of statement T433

12.10.2003.

FX orders: introduction of IBAN account number, country code and legal title code.

16.12.2004.

Multiple amount level means that there can be not only one securities, subaccount and main account total line but there can be several lines after one another, depending upon the KELER listing to which totals refer to. 2. Introduction

This document is prepared by Cardinal Kft. to the KID (KELER Interface Device) program operated in the KIS program of KELER Zrt. (earlier KELER Rt.). The document contains by subsystems the data format descriptions of statements, advices that can be imported into and exported from the KID program.

2.1. Importing orders

The KID allows the clients of KELER Zrt. to receive certain order types electronically into their own systems instead of manual input. If the client has a computer system where orders are input anyway, it does not have to enter items again in KID, it is enough to apply a predefined format to orders that KID will be able to interpret and convert to its own internal format.

Some important information provided below in relation to importing orders apply to all data.

Importing various order types has to be initiated in the own subsystem of the client.

Orders are to be put into separate data files based on their types and value dates. It means that for example funds transfer orders will be put into a file separate from the file of securities transfers. Within the same order type, if the settlement dates of the items differ the items have to be put into files with different names. Finally there is another important rule applicable to HUF transfer orders: in line with current requirements HUF transfers are to be separated based on the account number to be debited and put into separate files.

File names can be optional.

Files have a simple ASCII format, the program uses character set CodePage 852 to describe letters with accent. Basically they are made up by three important components. The first component is header. This contains one line the content of which is "HEADER". The second component contains the individual orders, the precise description of which will be detailed later. Generally speaking it is true that one order is to be given in one line and the lines describing the various items have to be of the same length. The third component is the closing line that indicates the file is ended. Its content is the text "TRAILER" that is followed by the number of items in the file, separated by spaces, in a line with a length of 5 characters.

The import format of orders can be changed very rarely (e.g. due to changes in the internal regulations of KELER Zrt.). In these cases changes in format are so that the clients of KELER Zrt. have to complete as little change in their own systems as possible:

- If newer, so far not existing data fields are to be entered, they will be put at the end of item lines.
- If an existing field is terminated, their place will have to be left empty (filled with spaces). (More precisely: the KID import module simply skips the positions of terminated fields, thus the data content is of no importance).

These two rules allow that the unchanged fields continue to be in the same positions, thus the change to be made in the exporting modules is as little as possible.

2.2. Exporting orders, statuses

From its version 5.02-69 the KID program allows orders sent to be exported with status information. The applicable export format will be fully identical to the order import format, the only difference is that at the end of the item lines status information will be shown. If due to changes in business processes at KELER new fields are added to the end of the item lines in the import format, the export format of order will be adjusted accordingly. The newly created fields in the export format will be added not to the end of the item line, but before status information. Thus it can be ensured that the export format is fully identical to the import format except for status information.

When exporting orders there are basically two formats that can be used. One describes the export of items in an order file, the status information valid at the time of exporting can be found in each line after the item information. The other format is status history. In case of status history the item line concerned is repeated as many times as the number of statuses assigned to the item. For the same item the lines following each other will differ in terms of status only.

2.4. Exporting statements, advices

The KID program allows clients to transmit electronically the various data types downloaded from KELER Zrt. to their own systems. If the client has a computer system where they can process information received from KELER, the client does not have to retype data, it is enough to convert them from the predefined format to the format of their own systems. This chapter details the format to be interpreted by the conversion program.

Important information related to data export is described here that applies to all data managed by the export module.

KID will put data based upon their type into separate data files. The names of export files can be optional. Users can change the name offered by the KID program.

Files have a simple ASCII format, the program uses character set CodePage 852 to describe letters with accent. Basically files are made up by three important components. The first component is header. This contains one line the content of which is "HEADER" and is followed by the date when it was made. The second component contains the items of exported data, the description of which will be detailed later. The export format of statements, advices, similarly to the import format of orders, consists of several lines of various types. Generally speaking it is true that the program provides one item in one line. Lines of the system type has the same length and structure. The type of the line can be ascertained from the first 8 characters. The third component is the closing line that indicates the file is ended. Its content is the text "TRAILER".
